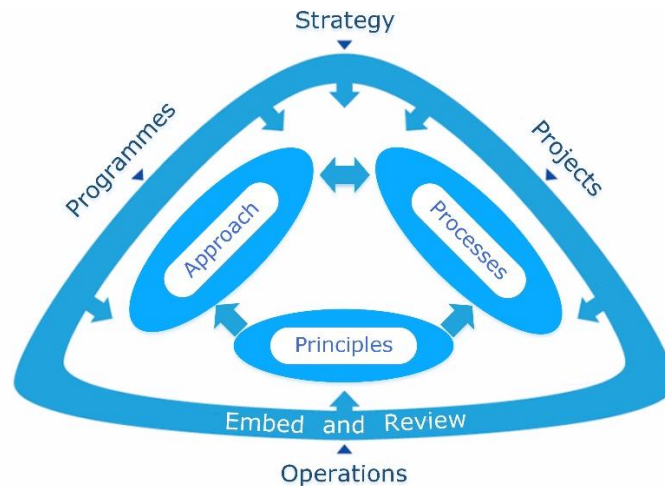

## M\_o\_R Foundation Course

Course Code	MORF3
Overview	<p>This course will cover the four core concepts: M_o_R Principles, Approach, Processes and Embedding &amp; Review. It incorporates all the activities required to identify and control the exposure to risk which may have an impact, positive or negative on the achievement of an organisation's business objectives.</p> <p>This course comprises three days of trainer-led instruction, and practical exercises, and the Foundation examination.</p>
Course Objectives	<p>This course will enable you to:</p> <ul style="list-style-type: none"> <li>• Understand the key principles underpinning the effective management of risk;</li> <li>• Apply the main components of the risk management process;</li> <li>• Appreciate how to manage risks at the Strategic, Programme, Project and Operational levels;</li> <li>• Utilise a range of techniques that can be used to support the management of risk process.</li> </ul> <p>Delegates will be fully prepared for the Foundation exam.</p>
Who Should Attend	Any organisation or individual seeing the need for guidance on a controlled approach to identifying, analysing and managing risk at strategic, programme, project and operational levels.
Prerequisites	There are no prerequisites for the course, however some exposure to risk management would be useful.
Course Content	<p>Foundation topics covered include:</p> <ul style="list-style-type: none"> <li>• Organisational context of risk management; governance and control;</li> <li>• Principles of risk management;</li> <li>• Approach: Policies, strategies and processes; planning; monitoring;</li> <li>• Perspectives: strategic; programme; project; operational ;</li> <li>• Risk Management Processes: Identifying and analysing risks; planning for implementation of countermeasures; communication ;</li> <li>• Embedding and Reviewing Risk Management: awareness; behaviours; commitment.</li> </ul> <p>The Foundation exam is a 60 minute closed book multiple choice exam. You must get at least 35 of the 70 questions correct to pass. We conduct the exams on behalf of APMG.</p> <p>There will be homework each evening.</p>
Included with the course	<p>The M_o_R Manual; Foundation Delegate Workbook including activities, discussions, quizzes and sample exams; Our M_o_R Desk Reference Chart; Foundation Exam; post-course support, including access to our alumni-only resources.</p> <p>Lunch, and morning and afternoon refreshments.</p> <p>A pre-course pack consisting of the Pre-Course Reading Guide and the M_o_R Manual can be sent to participants who complete registration at least 10 days before scheduled course start. We do recommend that participants complete 10 - 12 hours of pre-course reading, but this is not mandatory.</p>
Delivery	In-house classroom-style over 3 days. eLearning and blended offerings available
Availability	We offer M_o_R training for in-house groups only, generally in association with adoption of more robust risk management practices by an organisation.
