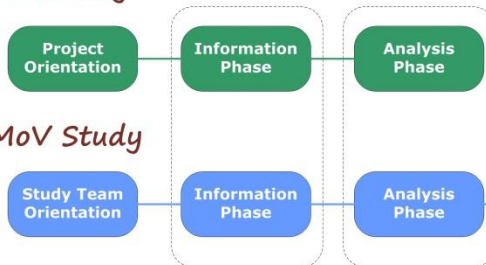

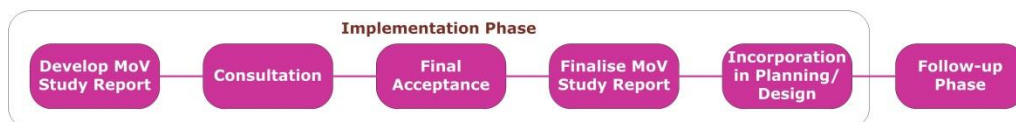

Overview	<p>MoV focuses on improving benefits and reducing expenditure to speed up delivery without impacting essential project scope or service quality. It is not simply about minimising costs. MoV is more focussed on maximising value in line with programme or project objectives. It captures key stakeholder requirements for what products should do rather than what they are. MoV is essential to effective policy making, programmes, projects, service reviews or product redesigns.</p> <p>This course comprises four days of trainer-led instruction, and practical exercises, with the Foundation and Practitioner examinations.</p>

This course will enhance delegates' understanding of a proven methodology which comprises a unique set of principles, processes and techniques.</p> <p>The course covers the MoV guidance at Practitioner level and provides coaching / practice questions, so that candidates can prepare themselves for the specific requirements of the MoV Practitioner examination.</p>
